

INDICTMENT FOR THE OFFENSES OF CAPITAL MURDER (Four Counts), FIRST DEGREE MURDER (Four Counts), ATTEMPTED MURDER, KIDNAPPING (Two Counts) and ARMED ROBBERY

THE STATE OF MISSISSIPPI, FOURTEENTH JUDICIAL DISTRICT COUNTY OF LINCOLN

IN THE CIRCUIT COURT OF SAID COUNTY, JANUARY TERM, 2018

The Grand Jurors of the State of Mississippi, taken from the body of good and lawful citizens of said county, elected, summoned, empaneled, sworn and charged to inquire in and for the body of the county aforesaid, at the term aforesaid of the court aforesaid, in the name and by the authority of the State of Mississippi, upon their oaths present that:

COUNT ONE

on or about the 27th or 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt did wilfully, unlawfully, feloniously and without the authority of law, kill and murder a peace officer, one Donald William Durr, a human being, at a time when Donald William Durr was acting in his official capacity as a Deputy for the Lincoln County Sheriff's Department, and at a time when Willie Cory Godbolt knew that Donald William Durr was a peace officer, by shooting the said Donald William Durr with a firearm, contrary to and in violation of Section 97-3-19(2)(a) of the Mississippi Code of 1972, as amended, this being count one of the indictment;

COUNT TWO

and on or about the 27th or 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with deliberate design to effect the death of one Brenda May, a human being, did kill and

murder in the First Degree the said Brenda May by shooting her with a firearm, contrary to and in violation of Section 97-3-19(1)(a) of the Mississippi Code of 1972, as amended, this being Count Two of the indictment;

COUNT THREE

and on or about the 27th or 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with deliberate design to effect the death of one Tocarra May, a human being, did kill and murder in the First Degree the said Tocarra May by shooting her with a firearm, contrary to and in violation of Section 97-3-19(1)(a) of the Mississippi Code of 1972, as amended, this being Count Three of the indictment;

COUNT FOUR

and on or about the 27th or 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with deliberate design to effect the death of one Barbara Mitchell, a human being, did kill and murder in the First Degree the said Barbara Mitchell by shooting her with a firearm, contrary to and in violation of Section 97-3-19(1)(a) of the Mississippi Code of 1972, as amended, this being Count Four of the indictment;

COUNT FIVE

and on or about the 27th or 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt did wilfully, unlawfully and feloniously design and endeavor to kill and murder Lincoln County Deputy Timothy Kees, a human being, without the authority of law and with the deliberate design to effect Timothy Kees's death and, in furtherance of his said design, Willie Cory Godbolt discharged a firearm at Timothy Kees, but Willie Cory

Godbolt failed in his said attempt to kill and murder Timothy Kees, all contrary to and in violation of Sections 97-1-7(2) and 97-3-19 of the Mississippi Code of 1972, as amended, this being Count Five of the indictment;

COUNT SIX

and on or about the 27th or 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously and without the authority of law, did forcibly seize and confine one Lapeatra Stafford, contrary to and in violation of Section 97-3-53 of the Mississippi Code of 1972, as amended, this being Count Six of the indictment;

COUNT SEVEN

and on or about the 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with or without any design to effect the death of one Jordan Blackwell, a human being, did kill and murder the said Jordan Blackwell, at a time when he, the said Willie Cory Godbolt, was then and there engaged in the commission of the crime of burglary of the dwelling house of Shon and Tiffany Blackwell (in violation of Mississippi Code Section 97-17-23), by breaking and entering the said dwelling house with the intent to commit therein the crime of assault upon one or more persons, contrary to and in violation of Section 97-3-19(2)(e) of the Mississippi Code of 1972, as amended, this being Count Seven of the indictment;

COUNT EIGHT

and on or about the 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with or without any design to effect the death of one Austin Edwards, a human being, did kill and murder

the said Austin Edwards, at a time when he, the said Willie Cory Godbolt was then and there engaged in the commission of the crime of burglary of the dwelling house of Shon and Tiffany Blackwell (in violation of Mississippi Code Section 97-17-23), by breaking and entering the said dwelling house with the intent to commit therein the crime of assault upon one or more persons, contrary to and in violation of Section 97-3-19(2)(e) of the Mississippi Code of 1972, as amended, this being Count Eight of the indictment;

COUNT NINE

and on or about the 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously and without the authority of law, did forcibly seize and confine one Xavier Lilly, contrary to and in violation of Section 97-3-53 of the Mississippi Code of 1972, as amended, this being Count Nine of the indictment;

COUNT TEN

and on or about the 28th day of May 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt, did wilfully, unlawfully and feloniously take from the presence of Henry Bracey and Alfred Bracey, against their will, a 2015 KIA motor vehicle, black in color and the personal property of Wykeshia Johnson, by putting the said Henry and Alfred Bracey in fear of immediate injury to their persons by the exhibition and of a deadly weapon, to wit: a firearm, contrary to and in violation of Section 97-3-79 of the Mississippi Code of 1972, as amended, this being Count Ten of the indictment;

COUNT ELEVEN

and on or about the 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with deliberate design to effect the death of one Ferral Burage, a human being, did kill and murder

in the First Degree the said Ferral Burage, by shooting him with a firearm, contrary to and in violation of Section 97-3-19(1)(a) of the Mississippi Code of 1972, as amended, this being Count Eleven of the indictment;

COUNT TWELVE

and on or about the 28th day of May, 2017, in Lincoln County, Mississippi and within the jurisdiction of this court, Willie Cory Godbolt wilfully, unlawfully, feloniously, without authority of law and with or without any design to effect the death of one Shelia Burage, a human being, did kill and murder the said Shelia Burage, at a time when he, the said Willie Cory Godbolt, was then and there engaged in the commission of the crime of burglary of the dwelling house of Ferral and Shelia Burage (in violation of Mississippi Code Section 97-17-23), by breaking and entering the said dwelling house with the intent to commit therein the crime of assault upon one or more persons, contrary to and in violation of Section 97-3-19(2)(e) of the Mississippi Code of 1972, as amended. this being Count Twelve of the indictment; all of said conduct alleged and set forth in counts one through twelve of this indictment having then and there been based on two or more acts or transactions connected together or constituting parts of a common scheme or plan, and against the peace and dignity of the State of Mississippi.
